1. **Entering this competition constitutes acknowledgement that current PCV rules apply and acceptance of these rules.**
2. **PCV Gear Check rules must be adhered to. All riders must have a gear check at least 20 minutes before their allocated time in each phase.** PCV Gear Check rules Jan 2019
3. **Complying helmets must be worn.** Current PCV gear rules apply. Complying helmets must be worn –ASSA3838 standard –EN1384 Standard, made in 2015 or earlier – VG1 standard – PAS015 Standard – ARB HS 2012 standard – ASTM F1163 standard
4. **Open Riders:**
  - a. Every rider competing in an Open section needs to complete a Liability Declaration Form (hand in on the day)
  - b. Participants need to pay \$10 Day Attendance Fee UNLESS they can provide proof that they are current financial members of:
    - ❖ Pony Club Association of Victoria;
    - ❖ Equestrian Australia\* (EA);
    - ❖ HRC AV
    - ❖ an Inter State Pony Club;
    - ❖ Arab Horse Society of Australia (AHSA);
    - ❖ Australian Endurance Riders Association (AERA); or
    - ❖ can provide proof that they are covered by Public Liability Insurance Policy with a minimum of \$10,000,000.00
  - c. Riders without adequate Insurance Cover pay \$10 for Liability Only cover for the duration of the event (not personal Medical) and complete the Day Participant Waiver
  - d. PCV Insurance Policy specifically states anyone not following PCV Rules may be left uninsured
5. **Refunds:** No refunds after closing date except with vet or medical certificate. These must be submitted to the club secretary no later than 7 days after the event
6. **The organizing committee** reserves the right to cancel any class or competition; divide any class; alter times; refuse any entry with or without stating the reason.
7. **PCV club member cards:** must be handed in to the secretary's office before riding. In accordance with PCV Bylaw 15.7.a .ii Grading must not be corrected or altered at a competition.
8. **Competitors may ride more than one horse competitively subject to ballot of entries.** Preferences will be based on listed order on entry form.
9. **Riders must be prepared** to ride before the allocated time in Dressage/Show Jumping/Cross Country
10. **HT competitors** cannot enter CT on the same mount in a different grade.
11. **Queries, protests, horse abuse rules:** All Queries must be lodged via the completion query form as per the PCAV Handbook of By-Laws. Jan 2019
12. **No Dogs Allowed** except with organizing committees approval
13. **Competitor numbers:** Competitors may supply their own bridle numbers displayed on both the left and right side of the bridle or saddlecloth numbers displayed on both the left and right side of the saddlecloth. Body numbers must be used for cross-country, organizing committee will supply body numbers.
14. **Long hair** must not obscure back numbers at any time.
15. **PCV Alcohol Policy** applies.
16. **PCV Smoking Policy** applies.
17. Neither the organizing committee of this competition nor the PCV accepts any responsibility whatsoever for any accident, damage, injury or illness to horses, riders, ground spectators or any other person or property.
18. **Presentations:** will occur after the final scores have been posted for 30 minutes
19. **Riders who do not stay for presentation MUST** provide \$3.00 for an envelope & postage and provide address details on the day or they will forfeit their prize/ribbon/rosette.
20. **Scoring:** equals separated as per PCV Handbook of bylaws Jan 2019
21. **Lungeing:** is permitted in enclosed arena. Riders need to be considerate of other riders needing to use the round yard and not use arena for more than 10 min if there are riders waiting.
22. **All Open Riders** are encouraged to email completed **LIABILITY DECLARATION FORMS** before the event. Riders who need forms on the day will be charged \$2.00 per form to cover printing costs.
23. **Cross Country Maps will not be printed.** Copies will be displayed on Facebook, MDHPC website and at the admin area on the day.
24. **Times will be posted on the Website after 6.00pm on 23/5/2019**

## DAY PARTICIPANT WAIVER 2018-2019

Participants in events organised by PCV Clubs, who are not current financial members of a PCV Club, or who do not have any other approved insurance in place, upon completion of this form are deemed to be "Day Participants" of the event.

Protection is afforded to the Day Participant under the PCV Public Liability policy, only whilst participating in activities organised and/or run by the PCV Club at that event, where they are liable for causing bodily injury or property damage to others, excluding whilst travelling to and from such event.

By signing this form, you agree to abide by the Rules & Conditions of the PCV and any Rules of the event. For every Entrant who does NOT have a current and proven Public Liability insurance to the minimum of \$10,000.00 a payment is due of \$10.00 per person per day (including GST), to cover the cost of participation with this Pony Club for each day of this event.

### Horse Sports are a Dangerous Activity

I, the undersigned, in consideration for being permitted to participate in any way in horse sport activities and in particular this event, acknowledge and accept that:

Horse sports are a dangerous recreational activity and horses can act in a sudden and unpredictable way, especially if frightened or hurt.

There is a significant risk that serious injury or death may result from horse sport activities and in particular this event and freely assume all such risks, even if arising from the negligence of PCAV and/or the event organiser / official.

I voluntarily participate at my own risk and assume sole responsibility for any injury, death or property damage I may suffer that arises from my participation in horse sport activities.

I understand and acknowledge the dangers associated with the consumption of alcohol or any mind altering drugs before and during the activity and I take full responsibility for any injury, loss or damage associated with their consumption. I agree to follow the directions of any event organiser or official and that any misconduct or refusal by me to follow any direction of any organiser or official can result in the cancellation of my participation in the event and my immediate removal from my horse no matter where that may occur. I further agree to abide by the Rules and Conditions of this event and the official Rule Book of the Pony Club Association of Victoria. I understand that any such non-compliance may result in injury, death and/or permanent disability and I agree to indemnify PCAV against all claims made by any person as a result of my failure to comply.

I agree to wear a helmet at all times whilst riding and agree that I am solely responsible for ensuring that I wear a suitable helmet at all times while riding and take sole responsibility for my actions.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless and agree not to sue the proprietors of the Pony Club Association of Victoria and/or the event organiser, their officers, officials, volunteers, coaches, agents and/or employees, other participants, sponsoring agencies, sponsors, state bodies, affiliated clubs and if applicable, owners and lessors of premises used to conduct the activities (all of whom are referred to as "Releasees") with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the Releasees or otherwise.

Effect of this Document - I have had sufficient opportunity to read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without inducement of any kind. I understand that my signature to this document constitutes a complete and unconditional release of all liability of the Releasees, to the greatest extent allowed by law in the event of me and/or the children under my care, suffering injury or death.

In consideration of your accepting my participation, I hereby undertake to indemnify the organising body against all claims, losses, suits and damages made against or suffered by the organising body by reason of any negligent act or omission on the part of any rider, driver, trainer or attendant whilst he/she is attending, riding, driving or otherwise handling any horse so entered or any other horse owned or entered by me, and I agree that any act or omission on the part of such rider, driver, handler or attendant found in any action against you to be negligent shall be deemed to have been negligent for the purpose of any claim under this indemnity.

Further, I agree to abide by the Rules & Conditions and current Rule Book as laid down by the Pony Club Association of Victoria and/or contained in any official event schedule and I also agree to abide by all of the Event Venue rules regarding use of their centre and its facilities.
